Electric Reliability Standards

The agreement became of the foundation of mandatory electric reliability standards that were enacted by Congress as part of the Energy Policy Act of 2005
- Developed and negotiated the Pacific Northwest Security Coordinator, an agreement among and



between electric balancing authority in the Western Interconnection for their coordination and oversight of electric balancing authorities

Power Marketing and Power Purchase Agreements

- Counsels on market based rate authority, Public Utility Regulatory Policies Act (PURPA), Qualifying Facility (QF), and Exempt Wholesale Generator (EWG) compliance
- Represents purchases and sellers in the negotiation of power purchase and sale agreements, electric storage agreements, transmission service agreements, and synthetic power purchase and sales agreements
